Minutes

Meeting called to order at 5:05 p.m. and closed at 6:45 p.m.

Chair of ESFLA: Lise Fontaine, presiding

- 1. Apologies for absence: Chris Gledhill, Julia Lavid
- 2. Minutes from the 2014 ESFLA AGM were presented and accepted as an accurate record.
- 3. Logo: Lise Fontaine shared on screen the design for the ESFLA logo, which needs further work to get desired shape.

Action: David Schönthal agreed to do the final graphic design.

- 4. Bertinoro 2012 update: publication *Hybridity in Systemic Functional Linguistics Grammar, Text and Discursive Context*, edited by Donna Miller and Paul Bayley is now at the typesetters.
- 5. Coventry 2013 update: on-line publication available *Language in a digital age: Be not afraid of digitality*; book publication in press with Equinox.
- 6. Report from ESFLC 2014 (Paris) by Chris Gledhill was shown. It was noted from the floor that it was a very well-organized conference. One publication (collection of papers in *TESOL International Journal*) now available. Another is in the planning.
- 7. A French translation of Halliday's work is being undertaken by Marion Bendinelli, who is also setting up a website with terminology in French. Collaboration is encouraged (directly or through Lise Fontaine or David Banks).
- 8. Treasurer's report by Robin Fawcett (see page 4).

 Lise Fontaine explained that Robin would be stepping down as treasurer of ESFLA, and thanked him for his long-time support of, careful attention to, and good advice for ESFLA's finances (followed by much applause and gratitude expressed).
- 9. Report from the Geoff Thompson as Chair of the Finance Working Group on possibilities for collecting subscriptions from members/benefactors of ESFLA. The group came up with four possibilities:
 - a. Continue as up until present, hoping that a conference does not suffer a loss.
 - b. In the case of a shortfall, make an appeal to members attending the ESFLC to contribute funds.

- c. Set up a system whereby members can support the Association by making contributions whenever they would like to.
- d. Set up a system whereby members can support the Association by making a contribution (set amount) which would then be deducted from the conference fee

A motion was proposed and seconded: ESFLA will proactively raise funds for various purposes (shortfalls, bursaries, projects).

In favour: 17, Abstaining: 4, Against: 1

Motion passed.

A second motion was proposed and seconded: ESFLA will set up a system of benefactors/supporters with a right to a reduction of the annual conference fee.

In favour: 1, Abstaining: 9, Against: 12

Motion denied.

A third motion was proposed and seconded: ESFLA will set up a system whereby members can provide monetary support as benefactors.

In favour: 17, Abstaining: 4, Against: 1

Motion passed.

Action: A sub-committee (Chair and Treasure of ESFLA, with Geoff Thompson as Head of the Finance Working Group) will work to write this decision into the Constitution.

A fourth motion was proposed and seconded: The ESFLA Executive Committee will hold the decision-making power for allocation of funds.

In favour: 15, Abstaining: 2, Against: 5

Motion passed.

10. Election of new ESFLA Committee members: in order to replace Chair, Treasurer and two of the European representatives (as Julia Lavid and Stella Neumann have stepped down), the following slate was proposed:
